

## **Acceptable Use Policy for Good Game Website**

**Last Updated:** April 12, 2025

This Acceptable Use Policy ("AUP") outlines the rules and guidelines for using the websites [www.goodgameshow.tv](http://www.goodgameshow.tv) and [www.gdgmtoken.com](http://www.gdgmtoken.com) (the "Websites") and any related services, features, content, applications, subscriptions, and e-commerce functionalities (collectively, the "Services") provided by Good Game Group INC ("we," "us," or "our"). By accessing or using our Services, you ("you" or "user") agree to comply with this AUP.

### **1. General Conduct**
